TASTING PAVILION TERMS & CONDITIONS

By signing the Tasting Pavilion Participation Form, each participant agrees to the following terms and conditions in addition to the Show's general exhibit terms and conditions:

Pavilion Hours

Sunday, April 22, 2018	10:00am - 5:00pm
Monday, April 23, 2018	10:00am - 4:00pm

Age Requirements

The Tasting Pavilion is open to attendees 21 years of age and over. Show Management will arrange for staff to check IDs at entrance to tasting area.

Server Permits

Each participating company is required to submit to Show Management the server permits of all individuals who will be pouring samples at the show by February 1. Additionally, servers must have a copy of their server permits on-hand for presentation at the show in the event of a visit by an OSLCB inspector.

Insurance

The participating company must have obtained and sent to Show management proof of a liquor liability endorsement of no less than \$1 million, naming Northwest Foodservice Show as an additional insured party.

Sample Sizes

Each participating exhibitor is required to provide appropriate sampling cups. Sample sizes are restricted to the following per OSLCB requirements:

Beer: No more than 2 ounces per serving.

Wine: No more than 2 ounces per serving.

Liquor: No more than ½ ounce per serving.

Ice Orders

Ice is not provided by Show Management. It is available for purchase through the facility.

Floor Covering & Furniture

Floor covering for booth or counter space is optional and may be provided by exhibitor or rented through official tradeshow decorator. Additional furniture is also available for rent through the tradeshow decorator.

Utilities

Utilities such as electrical services, water and drain hook-ups, or telecommunications services are not included with counters or booths, but may be ordered through the exclusive show service providers.

Compliance with Show Rules and Laws

All participating companies must adhere to all show policies, and city, state and federal laws governing the serving of alcoholic beverages. Exhibitor agrees to hold harmless and indemnify Show Management and all agents of the Northwest Foodservice Show for any fines or penalties resulting from Exhibitor non-compliance or violation of alcohol serving rules and regulations, or city, state or federal laws.

Cancellations & Refunds

No refunds are available after payment has been received.
